CGSA/Toro Assistant Superintendent of the Year Award

The Opportunity

The CGSA/Toro Assistant Superintendent of the Year Award recognizes the specific achievements of a golf course assistant superintendent whose performance and contributions to the success of the facility go beyond those that would normally be expected. The award is to be presented to an individual who has contributed to his or her golf facility in a significant way and who has demonstrated professionalism, leadership, innovation and a team approach in their work.

The Assistant Superintendent of the Year Award is open to CGSA member Assistant Superintendents, with a minimum of two years of experience working as an Assistant Superintendent. Nominations must be made by the superintendent or general manager at the facility at which the assistant is currently employed. The nominee must be an Assistant Superintendent member of the CGSA.

The Criteria

All applications must be submitted electronically using the CGSA/Toro Assistant Superintendent of the Year nomination form which follows this introduction.

The nominator must complete all fields in the nomination form, and include a maximum 500-word description, including pictures if applicable, of the ways in which the nominee has best demonstrated professionalism, motivation, leadership and the ability to significantly contribute to the operational success of the golf course management team at the facility. Please Include a copy of the nominee's resume with your submission as this is beneficial information for the Review Committee. The nominee should also possess the desire and the potential to eventually become a golf course Superintendent. Completed nominations must be submitted by midnight on **November 30, 2024**. Nominations received after this time may not be considered.

The Selection Process

A selection committee consisting of CGSA Superintendent members, with no obvious connection to any of the nominees, will be appointed to select the award recipient.

The Award

The Assistant Superintendent winner, chosen from among those nominated, will receive an All-Access registration to The 2025 Golf Course Management Conference (GCMC) in Niagara Falls, Ontario from February 25-27, 2025; 4 nights' accommodation at the Host Hotel and transportation costs to the conference location. Toro will also provide the winner with a \$500 CAD VISA gift card for meals and incidental expenses during the conference In addition, the recipient of the award will receive an Assistant Superintendent of the Year award plaque during the CGSA Awards Ceremony as part of the GCMC each year. The winner will also receive a 2025-2026 CGSA membership and The Toro Experience, an exclusive event hosted at The Toro Company Headquarters in Bloomington MN; including round-trip airfare and accommodations during the event.
