## CGSA/ENVU SUPERINTENDENT OF THE YEAR AWARD

The CGSA/ENVU Superintendent of the Year (SOTY) award is one of CGSA's most prestigious awards. The title is awarded to a superintendent who has been nominated by either a Provincial Golf Superintendent Association or by a CGSA member as a knowledgeable and competent member of the profession and who has been distinguished in the practice of golf course management. The winner of this award is chosen by an anonymous committee of peers.

### Qualifications:

- Must be a CGSA member and an active superintendent. Current members of the CGSA Board of Directors are ineligible to receive the award
- Must have been in the profession at least five years
- Has shown to be a willing supporter of CGSA
- Has brought honour to CGSA and his/her golf club on one or more occasions
- Be deserving of admiration and respect for performance as a superintendent.

### Nomination material:

- Official form
- Letters of Endorsement and support
- Each provincial golf superintendent association as well as any CGSA member is eligible to nominate one person who it believes deserves the title "CGSA/ENVU Superintendent of the Year". The nominators must provide the following:
  1. Three contributions that the nominee has made to CGSA
  2. At least one example of an action that has brought honour to either the CGSA or the member's golf club
  3. The personal endorsement of two members of the provincial association Executive Committee
  4. Three reasons why this person should be admired or respected for the work as a superintendent
  5. A maximum 200-word description of why the nominee deserves to receive the award
  6. Two high resolution photographs, one of the nominee and one of the golf course on which the nominee is employed, and
  7. **Email** the completed application form as well as any support materials to [lmicucci@golfsupers.com](mailto:lmicucci@golfsupers.com).

### The winner of this award will receive the following:

- Attendance at the Fall Field including golf as well as registration fee, travel costs, car rental, if necessary, and hotel accommodation for up to three nights;
- The recipient and their companion will receive an "All-Access" registration to *The Canadian* Golf Course Management Conference, 4 nights' accommodation at the conference hotel and transportation to the conference location;
- A site visit with a written agronomic report from an ENVU Green Solution Specialist;
- A \$5,000 ENVU plant protection package for the golf course\*; and
- The SOTY award winner and one guest will have the opportunity to visit ENVU's research facility in Clayton North Carolina, or similar educational opportunity. Trip will include a round of golf.

\*Must be an active Superintendent to qualify.

## CGSA/ENVU SUPERINTENDENT OF THE YEAR AWARD

### NOMINATION FORM

Each year from among nominees submitted by either a Provincial Association or by a CGSA member one superintendent is chosen by the Selection Committee, as the CGSA/ENVU Superintendent of the Year. The successful nominee is announced at the Canadian Golf Superintendents Association (CGSA) Fall Field Day and recognized at the annual CGSA *The Canadian Golf Course Management Conference* (CGCMC).

**In 2019 the CGSA Board of Directors approved that nominations could be submitted by either a Provincial Golf Superintendent Association or by any CGSA member.** A confidential selection committee made up of CGSA members will choose the CGSA/ENVU Superintendent of the Year award recipient from those nominated.

**\*Please note: This form must be completed, and the accompanying support materials and must be in the form and style governed by the CGSA Board of Directors or it will be returned. Information and photographs received by the CGSA cannot be returned. Deadline for submissions is June 30th. Any received after the deadline will be considered for future years. (CURRENT BOARD MEMBERS ARE INELIGIBLE.) All non-successful nominations are retained for the following year unless the Provincial association submits an alternate nomination, or the criteria of the nominee has changed.**

If all the information is not received, the nomination form will be returned to you for completion. All nominations will be acknowledged.
